I understand that:

- a. There must be at least two people at the pool at all times of operation in order to swim.
- b. Pool usage is restricted to the hours posted at the pool area.
- c. The Association will enforce the pool rules, when necessary, and may ask persons to leave the pool area who continue to violate the rules after being asked to stop. Any continued **violation should be reported to The Select Group at 486-6000** for possible revocation of pool privileges.

POOL RULES

POOL OPENS FROM MEMORIAL DAY THROUGH LABOR DAY

1. POOL HOURS ARE FROM 7:30 A.M. UNTIL 10:00 P.M. DAILY.
2. THE POOL IS FOR THE EXCLUSIVE USE OF UNIT OWNERS AND THEIR GUESTS. PLEASE LIMIT GUESTS TO FOUR (4) PERSONS PER HOUSEHOLD.
3. PERSONS WITH SKIN CONDITIONS, OPEN SORES, INFLAMED EYES, OR NASAL/EAR DISCHARGE MAY NOT SWIM IN THE POOL.
4. PETS ARE NOT PERMITTED IN THE POOL AREA.
5. TRASH MUST BE PLACED IN CONTAINERS PROVIDED IN THE POOL AREA.
6. NO GLASS, BREAKABLE CONTAINERS, ALCOHOLIC BEVERAGES, FOOD, OR GRILLS ARE PERMITTED IN THE POOL AREA.
7. DIVING IS PROHIBITED.
8. MUSIC VOLUME MUST BE KEPT AT A LEVEL NOT OFFENSIVE TO OTHERS.
9. NO RUNNING, PUSHING, ROUGH PLAY, OR PROFANE LANGUAGE IS PERMITTED.
10. VIOLATION OF THESE RULES WILL RESULT IN SUSPENSION OF POOL PRIVILEGES. PLEASE REPORT ALL VIOLATIONS TO THE ASSOCIATION MANAGER AT 486-6000.
11. RESIDENTS ARE REMINDED THAT THERE IS NO LIFE GUARD OR POOL ATTENDANT ON DUTY AND SWIMMING IS DONE AT YOUR OWN RISK. THE ASSOCIATION MAY ASK VIOLATORS OF THESE RULES TO LEAVE THE POOL AREA.
12. OWNERS WHO ALLOW NON-RESIDENTS TO USE THEIR POOL GATE CODE WILL HAVE THEIR PRIVILEGES SUSPENDED AND THEIR CODE DISABLED UNTIL A COVENANTS HEARING IS HELD.
