When the pool season begins, the time frame allowance of parties is:

- > 8:00 p.m. to 12:00 a.m. on Fridays, Saturdays, and Holidays
- > 7:00 p.m. to 12:00 a.m. on Mondays (except on Holidays), Tuesdays, Wednesdays, Thursdays, and Sundays. **NO LATER!!**

If using the clubhouse only, maximum number of people permitted is 35.

If using the pool and clubhouse, the maximum number of people in the water is 54. The number of attendees will also determine how many lifeguards will be required. This is a City of Virginia Beach Code that the pool service must adhere to and the liability the Association must follow with the master insurance coverage.

<u>Allowed to bring into pool area</u>: Food, beverages, coolers, cans, plastic bottles and containers, additional chairs, radio, additional trash bags.

NOT allowed to bring into pool area:

- ➤ No large boom boxes or live bands.
- ➤ No glass of any kind.
- No charcoal grills. Cleanup <u>must be provided</u> for any grills brought to the parking lot area.
- ➤ No coals to be distributed into the flower beds, parking lot or common areas surrounding the pool.
- ➤ If a fire results from hot coals, the person having the party will be held liable for any and all damages.

<u>In using the clubhouse only</u>: The hours of use are the same as for the pool. By 11:30 p.m. the party should be coming to a close in order for all items to be cleaned up and put back in their proper place for the next day's pool operation.

<u>Please note: You will be held liable for damage to walls, carpeting, etc. up to and including replacement. All leftover food and beverages must be removed from the pool and clubhouse areas after the event.</u>

If the function is a pool party, the Lifeguard has the right to end the party at 11:30 p.m. to allow time for clean-up to be completed by 12:00 a.m. **No Exceptions!**

If, at any time, a pool party becomes too noisy/unruly, the Lifeguard has the right to notify the person in charge of the party to keep the noise down and keep the party under control or the party can be closed down. If an owner or resident fails to comply in this request, the Lifeguard has the authority to close the party and/or to contact the police contacted and have persons escorted from the pool.

In submitting your security deposit, you may do so by check payable to Herons Cove Condominium Association. The check will be held until the inspection of the pool and clubhouse is completed. If no damages are found, the check will be voided and returned.

Please remember the Lifeguard on duty for a pool party <u>is not responsible for cleanup</u>, this is the responsibility of the person holding the event. All trash should be placed in the proper trash receptacles for the Lifeguards to place out on Tuesday and Friday for trash pickup. This applies to clubhouse only parties as well. Your cooperation is appreciated.
