They may be picked up at The Select Group during normal business hours. **Decal and guest passes are not transferable between residents.**

Neither Effingham Green II Condominium Association, Inc. nor The Select Group, Inc. is responsible for vehicles that are backed into the parking space or that are not properly displaying a parking decal or guest pass.

### **Parking Rules (from the Association's Rules and Regulations)**

17. An owner shall not use, or allow his family or guests, to use parking spaces of the other owners. All vehicles in the parking lot must have current registration, inspection, and licenses, and cannot be in disrepair. Storage of vehicles for extended periods of time will not be permitted. The Association reserves the right to remove such vehicles without notice, at the expense of the respective vehicle owners.
18. The owners shall not cause or permit the blowing of any horn from any vehicle in which his guest shall be an occupant, approaching or upon any of the driveway or parking areas serving the building except as maybe necessary for the safe operation thereof.
