No Pets will be permitted on the premises or in the Units except those registered with the Board of Directors, and subject to the following rules:

- No more than two 2 dogs, 2 cats, or one dog and cat per unit without **“prior”** written Board approval.
- Pets cannot weigh no more than fifty pounds (50-lbs.) without **“prior”** written Board approval.
- Any pet causing or creating a nuisance or unreasonable disturbance or noise may be permanently removed from the property upon ten (10) days written notice.
- Pet droppings must be promptly removed by owner of the pet.
- All pets shall be inoculated as required by law.
- All pets must be sufficiently under control at all times so that they do not become a nuisance to the unit owners or occupants of other units.
- No pets shall be tied or leashed to any part of the Common Elements.
- No pets shall be left unattended on any deck, balcony, patio or any portion of the Common Elements.
