

CLUBHOUSE USE AGREEMENT AND RELEASE (DOES NOT INCLUDE POOL USAGE)



- 7. I VOLUNTARILY ASSUME all risks of loss, damage, or injury (including death) that may be sustained by me, my guests or relatives or the property of any of the above while on the property of any of the above while on the premises.
- 8. I agree to repair or pay for repairs for all damage resulting from my use of the premises.
- 9.. I understand that Water Oaks will not assume responsibility or reimburse me for any of the expenses involved for the activities conducted.
- 10. I understand any wall decorations must be hung only on provided hooks.
- 11. I understand that if there is music, it is an Association rule that the music be contained WITHIN the clubhouse, at a reasonable decibel level, and that there is an 11:00 pm curfew for noise.
- 12. I agree to return the premises to their original state, clean and free of litter with trash bagged and deposited as directed.

Resident or Sponsored Event (i.e., Weddings, Political, or Club). Private parties or similar functions are normally held in one's home. There may be two free (no fee) events not to exceed 50 People, per unit, per calendar year. Additional member events may be scheduled under the following conditions:

- 1. Large events: more than 25 and no more than 50 people, \$150.00 rental fee, \$150.00 security deposit, and \$100.00 Clean-up fee.
- 2. Small events: up to 25 people, \$50.00 rental fee, \$50.00 security deposit, and \$75.00 Clean-up fee.
