- Copies of any permits if required by city or state.

Non-returnable paint samples are required for all exterior colors to be used or stain for decks and fences. For any building or storage shed, exterior walls, trim and roof shingles colors will be required to match as close as possible to the exterior color of the existing structure, and samples will also be retained for the committee records.

The ARC has thirty (30) days from receipt of this form to reply to your request. Please be sure to include all information and a phone number so that you may be contacted should additional information be required.

Upon approval of your request, the homeowner agrees to complete the alterations or additions within one (1) year from the date of approval. The homeowner agrees to comply with all applicable County, State, and City building codes and laws, and to obtain all necessary building permits and approvals and inspections required.
